NEW BUSINESS

This Public Hearing is for variance requests submitted by Ian Daykin requesting a two-story deck. Specifically, a 3.7-foot variance for the proposed upper deck and 13.7-foot variance for the covered lower deck that encroaches upon the front setback. Unenclosed and uncovered decks may encroach upon the required front setback by up to 10 feet in accordance with Section 3.07.B,1. a and 3.07.B.3 of the Pentwater Community Zoning Ordinance The applicant is proposing that the two-story deck would be setback 16.3 feet from the front lot line.

Jean Russell asked for any questions from the Zoning Board. Stanley Roose asked if the decking was all around the house. Jean Russell stated it was a Non-Waterfront Property. Jean Russell then asked Keith Edwards for any comments from people living within 300 feet of said request. Listed below are the letters Keith Edwards received:

Randy Hepworth stated it keeps in line visually with all the immediate neighbors.

There was some discussion over the existing setbacks of neighboring properties and the line of site from neighbor's homes to views of Lake Michigan. Jean Russell asked for a motion. Randy Hepworth made a motion to approve the variance requests with a condition of proposed cable railing as Mr. Daykin illustrated at the meeting. Mike Flynn seconded.
